Stiles, Licensed Land Surveyor, entitled "CARMEL MOUNTAIN RANCH UNIT NO. 31 being a subdivision of a portion of Pompeii Farms per Map No. 1738, approval of said map revoked per City Council Resolution No. 203023 adopted October 12, 1971, a portion of Rancho de los Penasquitos and a portion of Section 16, Township 14 South, Range 2 West, San Bernardino Meridian, all in the City of San Diego, County of San Diego, State of California," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.


