of high speed pursuits, patrol of high crime areas, and certain
assistance in fire fighting missions, and

WHEREAS, Special Fund 10132, Seized and Forfeited Assets has been established for deposit of the proceeds of all assets received by the City through the Federal Forfeiture Program, said assets to be used for law enforcement purposes, NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is and is hereby authorized and empowered to establish a Police Helicopter Patrol Program.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized to expend the amount of not more than \$170,706

from Special Fund 10132 solely and exclusively for the purposes of helicopter and crew equipment costs and operating costs for approximately 1000 flight hours for the Police Helicopter Patrol Program.
