WHEREAS, the U.S. Department of Housing and Urban Development (HUD) requires Community Development Block Grant recipients to affirmatively further fair housing through specific activities which will reduce, eliminate or prevent housing discrimination; and


WHEREAS, the City Council has previously adopted two fair housing policies, Council Policy 600-19 Fostering of Balanced Community Development for The City of San Diego, and Council Policy 600-20, Open Housing, which are consistent with the federal requirement; and

WHEREAS, the proposed program will further both federal and local fair housing goals; and

WHEREAS, the San Diego Housing Commission endorsed adoption of this Affirmative Fair Housing Program on March 16, 1987; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the 1987 Affirmative Fair Housing Program, a copy of which is on file in the office of the City Clerk as Document No. RR-268054, is hereby approved.
