WHEREAS, Clarence Hurlbert (deceased) made and is now recognized for his outstanding individual contribution to San Diego Transit; and

WHEREAS, this award is particularly meaningful in that it is given in the Centennial Year of Public Transportation of San Diego, which began with the San Diego Street Car Company; and

WHEREAS, Mr. Hurlbert joined the San Diego Electric Railway Company as a Street Car/Bus Operator on October 7, 1937, earning 57 cents per hour; and

WHEREAS, Mr. Hurlbert was with the company for 43 years and was liked and respected by everyone; and

WHEREAS, Mr. Hurlbert was promoted to Supervisor in 1942, and to Superintendent of Transportation, in 1972; and

WHEREAS, Mr. Hurlbert was responsible for a Department of 600 employees; and

WHEREAS, Mr. Hurlbert had a unique ability to direct employees back on track without alienating them from him or the company; and

WHEREAS, Mr. Hurlbert passed away in 1984; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council does hereby present this Resolution of Commendation to the family of Clarence Hurlbert on this day of April 18, 1987 as he is inducted into the San Diego Transit "Hall of Fame."
