
RESOLUTION NUMBER R- 268084

ADOPTED ON APR 7 1987

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those public rights-of-way for pedestrians and non-motor vehicle deeds of PACIFIC MARKET INVESTMENT COMPANY, a joint venture, bearing date of January 6, 1987, and of SAN DIEGO UNIFIED PORT DISTRICT, a public corporation, bearing date of December 15, 1986, executed in favor of The City of San Diego, copies of which deeds are on file in the Office of the City Clerk as Document Nos. RR-268084-/ and RR-268084-², granting to said City a right-of-way for public walkway and non-motor vehicular purposes in a portion of Lots A-F, Block 31, and Lots G-L, Block 32 of Map 456, as more particularly described in said deeds, and shown on Drawing No. 16874-B, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public walkway.

BE IT FURTHER RESOLVED, that the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
