1. That the low bid of PPG INDUSTRIES, INC. meeting specifications is hereby accepted and the City Manager is hereby authorized to execute a contract for the purchase of LIQUID CAUSTIC SODA as may be required for a period of one (1) year beginning July 1, 1987 through June 30, 1988 at a cost of \$161.00 per ton, for a total estimated cost of \$255,587.50; terms net 30 days, plus applicable sales tax.
2. That the Purchasing Agent is hereby authorized to purchase liquid caustic soda on an emergency basis, in the event the contract vendor fails to deliver caustic soda on any occasion, from Van Waters & Rogers, All Pure Chemical, Imperial West Chemical, Stauffer Chemical, GPS, Western States Chemical and/or Crown Chemical, per prices on file in the Purchasing Department.
