APPROVING MAP OF WEBB'S VISTA DE
CORONADO.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain map surveyed by James H. Algert, Registered Civil Engineer, entitled "WEBB'S VISTA DE CORONADO being a subdivision of a portion of Lot 16 of South San Diego Heights, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 519, filed in the office of the County Recorder of San Diego County March 28, 1888," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Grove Avenue and said portion of street is hereby declared to be a portion of public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, that said portion of street is accepted on behalf of the public as heretofore stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
