RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO, CALIFORNIA, MAKING APPOINTMENTS IN
CERTAIN SPECIAL ASSESSMENT REFUNDINGS.

WHEREAS, the City Council of the City of San Diego,
California, did previously undertake proceedings and confirmed
assessments in certain special assessment districts pursuant to
the terms and provisions of the "Municipal Improvement Act of
1913," being Division 12 of the Streets and Highways Code of the
State of California, and issued bonds pursuant to the terms and
provisions of the City of San Diego Improvement District
Procedural Ordinance of 1982 (Division 23, San Diego Municipal
Code), and applicable Sections of Division 10 of the Streets and
Highways Code of the State of California); and

WHEREAS, the legislative body now desires to initiate
proceedings to refund all outstanding improvement bonds pursuant
to the "Refunding Act of 1984 for 1915 Improvement Act Bonds,
being Division 11.5 of said Code for the following Assessment
Districts to be known and designated as:

Assessment District No. 3879-R

(Mira Mesa Boulevard between Parkdale Avenue
and Lusk Industrial Park Refunding)

Assessment District No. 3960-R

(Alta Vista Annexation Water and
Sewer District Refunding)

Assessment District No. 3969-R

(Rio Vista Center Refunding)

Assessment District No. 3970-R

(Carroll Canyon Center Refunding)

Assessment District No. 3975-R

(Sunset Cliffs Shoreline Stabilization Refunding)

Assessment District No. 3990-R

(Lopez Canyon Sewer and Retention Basin Refunding)

WHEREAS, at this time, this legislative body is desirous of making the required appointments and designating persons to perform certain duties, in order to allow the proceedings to go forward to completion in accordance with the provisions of law; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

SECTION 1. That the above recitals are all true and correct.

SECTION 2. That THOMAS MEADE is hereby appointed to perform all of the duties and functions of the Superintendent of Streets for the above-referenced Assessment District.


SECTION 3. That the place for recordation of the reassessment roll and diagram shall be in the office of the Superintendent of Streets, and said reassessment roll and diagram, upon recordation, shall be kept as a permanent record.

SECTION 4. That BROWN & DIVEN, Attorneys at Law, is hereby appointed to act as Bond Counsel for the purposes of preparing proceedings and issuing an approving opinion attesting to the validity of the proceedings and the enforceability of the bonds,

pursuant to the terms and provisions of a Special Counsel Agreement submitted herewith, which Agreement is hereby accepted and approved for execution.

SECTION 5. That STONE & YOUNGBERG is hereby appointed to act as Underwriter and Investment Banker for the purposes of purchasing the bonds to issue for said proceedings, and it is hereby requested that a formal Purchasing Agreement be prepared and submitted for review.
