WHEREAS, the vacation of the City's interest in an unneeded general utility easement affecting Lots 35-43 of Carmel Valley Unit 7, Map 11544, as more particularly shown on Drawing No. 16848-B attached hereto as Exhibit "A", has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement has never been used, and is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the general utility easement, as more particularly shown on the drawing attached hereto, is hereby vacated.
- 2. That this resolution shall not become effective unless and until the final Lot Line Adjustment Parcel Map, TM 86-0754 has been approved by Council action. In the event the final parcel map is not approved by three years after adoption, this

resolution shall become void and be of no further force or effect.

3. That the City Engineer shall advise the City Clerk of the approval of the aforementioned subdivision map, and that the City Clerk shall then cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
