
RESOLUTION NUMBER R- 268146

ADOPTED ON APR 20 1987

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with LENOJAC, INC., a California corporation, for the dedication of approximately 1.81 acres of City-owned land, being portions of Lots 63, 64 and 67 of El Cajon Valley Company's lands, Map 289, for public street purposes, in return for LENOJAC processing a parcel map on an adjoining piece of City-owned property and providing the property with an improved roadway, including underground utilities, under the terms and conditions set forth in that agreement on file in the office of the City Clerk as Document No. RR- 268146-1

BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized and empowered to execute an easement deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 268146-2, transferring to the COUNTY OF SAN DIEGO, those portions of Lots 63, 64 and 67 of El Cajon Valley Company's lands, Map 289, for public street purposes.
