- 3. That the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$44,597.88 to supplement the project contingency reserves.
- 4. That the expenditure of an amount not to exceed \$16,519 from Industrial Fund 30248, Pueblo Lands Development, CIP No.

39-040, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
