RESOLUTION NUMBER R- 268153

ADOPTED ON APR 20 1987

WHEREAS, on March 2, 1987, the Local Agency Formation Commission (LAFCO) considered the adoption of a sphere of influence for portions of The City of San Diego's boundaries and the designation of seven special study areas; and

WHEREAS, at the request of City staff, LAFCO continued the matter two months, to their May 4, 1987 meeting, to allow Rules Committee and City Council review prior to LAFCO action on the proposed sphere; and

WHEREAS, LAFCO is required by the Cortese/Knox Reorganization Act of 1985 to adopt a sphere of influence for each local governmental agency in the County within LAFCO jurisdiction; and

WHEREAS, LAFCO is proposing the adoption of a coterminous sphere of influence where the City's boundary abuts another city's boundary and an adopted sphere of influence; and

WHEREAS, seven special study areas are proposed in areas where San Diego's boundary abuts another city without an adopted sphere of influence or where the City abuts unincorporated territory; and

WHEREAS, the matter has been thoroughly discussed in Planning Department Report No. 87-135 to the Rules Committee, said report dated March 12, 1987; and


WHEREAS, on March 18, 1987, the Rules Committee reviewed and approved the recommendations contained in said report and now

forwards the matter to the full Council with a recommendation to adopt; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation contained in Planning Department Report No. 87-135, dated March 12, 1987, concurred in by the City Manager and approved by the Rules Committee on March 18, 1987 concerning approval of support of the proposed sphere of influence for The City of San Diego and designation of seven special study areas, be and the same is hereby approved.
