BE IT RESOLVED, by the Council of The City of San Diego, that the transportation of City employees and School Safety Patrol members is hereby authorized under the following conditions:

City is obligated to share equally with the San Diego Unified School District liability in excess of School District's insurance policy limits of \$5 million arising out of the negligent acts of City employees or Safety Patrol students while the foregoing are being transported on School District buses to and from summer camp at the Palomar Mountain School Camp, during the period June 22, 1987 through July 17, 1987.
