BE IT RESOLVED, by the Council of the City of San Diego that all bids on Bid No. 6218M - CONSTRUCTION OF WABASH NEIGHBORHOOD PARK IRRIGATION IMPROVEMENTS theretofore received on October 3, 1985, for CONSTRUCTION OF WABASH NEIGHBORHOOD PARK IRRIGATION IMPROVEMENTS are hereby rejected.

BE IT FURTHER RESOLVED, that the revised plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF WABASH NEIGHBORHOOD PARK IRRIGATION IMPROVEMENTS filed in the office of the City Clerk of the City of San Diego, California, on April 27, 1987, and bearing official Document No. W.O. 118550, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.


BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF WABASH NEIGHBORHOOD PARK IRRIGATION IMPROVEMENTS in accordance with the specifications.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$40,000 from the Mid-City Park

Development Fund 39094 to CIP No. 29-471 WABASH NEIGHBORHOOD PARK  
- IRRIGATION SYSTEM.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$40,000 from Mid-City Park Development Fund 39094, CIP No. 29-471 WABASH NEIGHBORHOOD PARK - IRRIGATION SYSTEM, to supplement funds previously authorized by Resolution No. 263965, adopted on September 9, 1985, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
