RESOLUTION NUMBER R- 268185

ADOPTED ON APR 27 1987

THE VACATION OF A PORTION OF ALBATROSS STREET NORTH OF UNIVERSITY PLACE; A PORTION OF UNIVERSITY PLACE EAST AND WEST OF ALBATROSS STREET; AND A PORTION OF THE NORTH/SOUTH ALLEY ADJACENT TO LOT 16 OF BLOCK 3, MAP 1023 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the public interest and convenience of said City require the vacation of a portion of Albatross Street north of University Place; a portion of University Place east and west of Albatross Street; and a portion of the north/south alley adjacent to Lot 16 of Block 3, Map 1023, hereinafter mentioned.

2. That it is the intention of said Council to order the vacation of a portion of Albatross Street north of University Place; a portion of University Place east and west of Albatross Street; and a portion of the north/south alley adjacent to Lot 16 of Block 3, Map 1023, as more particularly shown on Drawing No. 23437-D on file in the office of the City Clerk as Document No. RR- 268185.


3. That this Council hereby elects to proceed, in making said vacation under the provisions of the "Public Streets, Highways, and Service Easements Vacation Law."

4. That this Council hereby fixes 2:00 p.m. on June 2, 1987, in the Council Chambers on the twelfth

floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.

5. That The Daily Transcript, a daily newspaper published and circulated, and of general circulation, in said City of San Diego, be, and it is hereby designated as the newspaper in which the Street Superintendent of said City shall cause to be published, in the manner and form required by law, notice of the passage of this Resolution of Intention, and the Street Superintendent is hereby directed to cause notices of the passage of this resolution to be posted in the manner and form required by law and to cause a notice similar in substance to be published in said newspaper in the manner required by law.
