
ADOPTED ON APR 27 1987

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, effective between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on both sides of Cliffridge Avenue between Glenbrook Way and Robin Hood Lane; both sides of Dunaway Drive between Glenwick Lane and Torrey Pines Road; both sides of Robin Hood Lane between Glenbrook Way and the cul-de-sac south of Glenbrook Way; and both sides of Glenbrook Way between Torrey Pines Road and Nottingham Place.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.
