WHEREAS, the vacation of the City's interest in an unneeded general utility easement affecting portions of Burton Street and Coolidge Street vacated, as more particularly shown on Drawing No. 16933-B attached hereto as Exhibit "A", has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement is being replaced by new easements granted on Parcel Map T.M. No. 86-0685; and

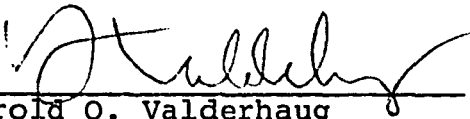

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

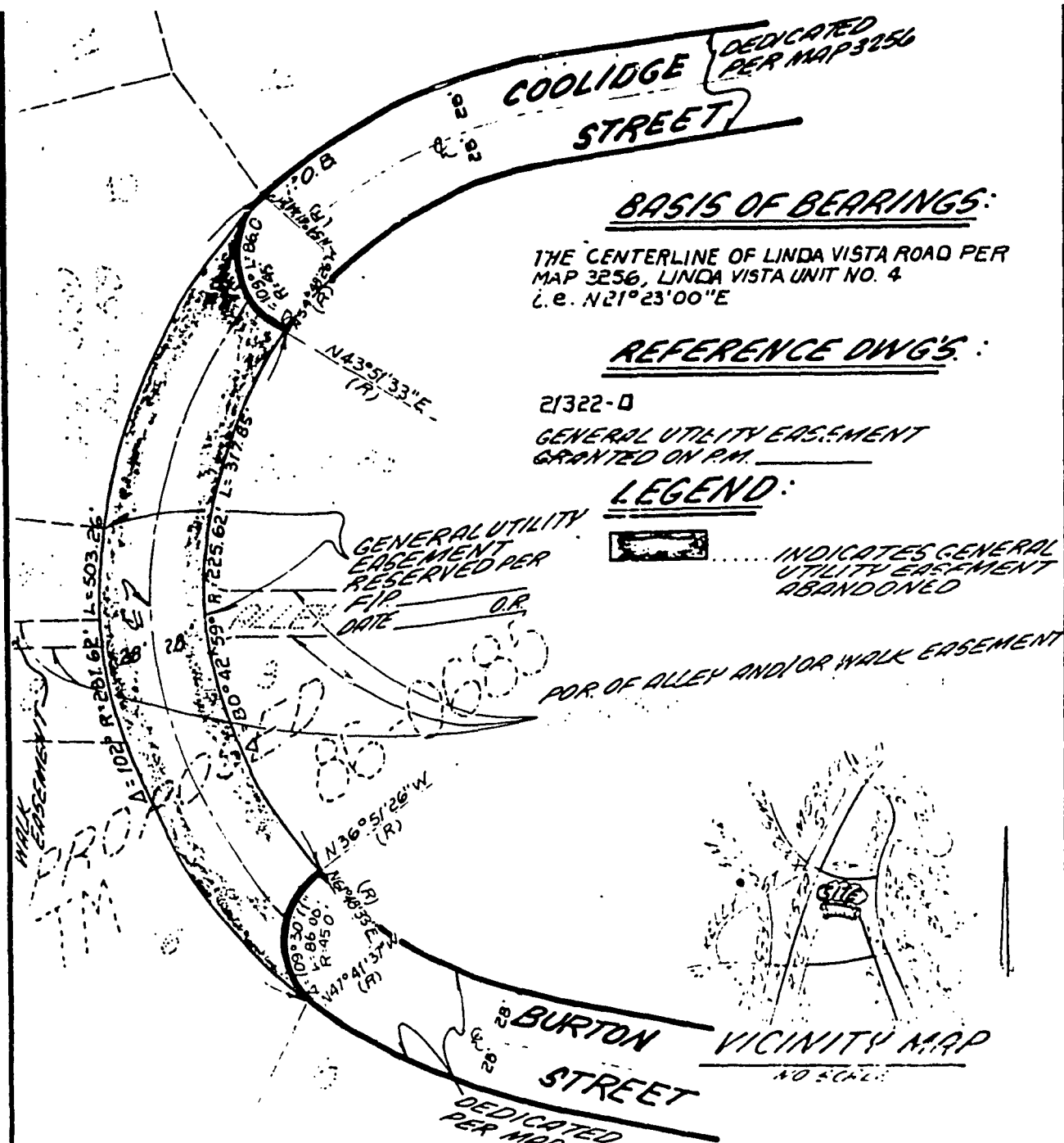
