execute, for and on behalf of said City, an agreement with Ralph Andersen and Associates to provide executive recruitment services for the Planning Director of The City of San Diego, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. RR-268235 -2 and pursuant to the processes set forth in its proposal to the City Council, a copy of which is on file in the office of the City Clerk as Document No. RR-2682351.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$18,000 from Dept. 605, Org. 100, Account 4903 is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
