Jack Salfen	Utilities	\$160.00	Mr. Salfen is a Wastewater Plant Lead Operator in the Metro Division. He suggested the installation of a concrete pad at the Westend of the headworks area sloping to the manhole. Although savings are difficult to identify, this is considered to be a significant operational improvement.
James Bolen	Police	\$160.00	Mr. Bolen is a Detective in the Traffic Division. He suggested the Traffic Investigations Unit follow-up on serious injury accidents. Although savings are difficult to identify, this is considered to be a significant operational improvement.
Carmen Lutes	Building Inspection	\$123.93	Ms. Lutes is the Principle Clerk. She suggested showing the inspector's name and phone number on the PMT02U screen. Actual savings of \$3,713.10 in time has been realized. This is the remainder of her award.
