ADOPTED ON MAY 4 1987

WHEREAS, Patrick Henry High School is one of the top ten schools in California in the number of students taking and passing the Advanced Placement Exams; and

WHEREAS, Patrick Henry High School has produced each year over the last eight years, multiple valedictorians as a result of equal academic achievement; and

WHEREAS, Patrick Henry High School has produced over 150 winners of the Triple E Award over the last ten years; and

WHEREAS, Patrick Henry High School seniors annually garner over \$1 million worth of scholarships toward higher education; and

WHEREAS, the award winning Patrick Henry High School Band has twice represented The City of San Diego in the Tournament of Roses Parade in Pasadena within the last five years; and

WHEREAS, the elite Bel Cantos Ensemble annually walks away with top honors for their expertise in city, state and inter-state competitions; and

WHEREAS, the Patrick Henry High School Speech Team is the only one in the city that has produced eleven qualifiers and a winner in the National Speech Competition in one or more categories in the last twelve years; and

WHEREAS, the Patrick Henry High School Speech Team annually sponsors one of the largest speech competitions in the western

states, "The Christmas Classic", with competitors from all over California with entries from Arizona, Nevada, and Utah; and

WHEREAS, sports teams from Patrick Henry High School have captured more than their fair share of league titles, All-Conference titles and CIF titles over the years and have retired the U.S. Marine Corps trophy for all-around athletic excellence after winning it ten years in a row; and

WHEREAS, the Drama Department from Patrick Henry High School has won countless acting competitions in Southern California competitions; and

WHEREAS, Patrick Henry High School has no less than one and as many as five appointments per year to the nation's military academies on full scholarships and have had as many as eight graduates in one academy at the same time; and

WHEREAS, the Academic Decathlon Team from Patrick Henry High School has been a consistent top placement qualifier in county and state competitions over the last five years; and

WHEREAS, the Patrick Henry High School Library has pioneered the computerized electronic mail concept between local students and students nationwide and internationally; and

WHEREAS, Patrick Henry High School produces National Merit Scholarship winners and finalists, including the twelve this year who all qualified as finalists; and

WHEREAS, parent support groups at Patrick Henry High School such as the Academic Boosters, PTA, Football Boosters, Chemical People and Band parents are the most active and supportive groups to be found anywhere; and

WHEREAS, Patrick Henry High School Vocational Careers Office is one of the most active and successful in the city; and


