WHEREAS, the economic health of San Diego depends in large measure on the prospects of the area's small businesses, and the entrepreneurship, productivity and innovations of men and women engaged in small business constitute the vital core of the economy of America's Finest City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby acknowledge and applauds the special contributions made to small business by the Small Business Development Center of the Greater San Diego Chamber of Commerce.

BE IT FURTHER RESOLVED, that the Council also commends the Center's continuing efforts to assist in the development of San Diego small businesses and conveys sincere and best wishes for every success in the future.

BE IT FURTHER RESOLVED, that a suitably prepared copy of this resolution be transmitted to the Small Business Development Center of the Greater San Diego Chamber of Commerce.
