WHEREAS, the City Council established a Committee Against Drug Abuse (herein called "Committee") by Resolution No. R-267727, dated February 17, 1987; and

WHEREAS, said resolution also directed the City Manager to recommend to the Council a consultant to support said Committee and prepare an agreement with consultant for necessary services; and

WHEREAS, said resolution further authorized the Auditor and Comptroller to transfer to the appropriate account the sum of \$100,000 to defray the expenses associated with the Committee and Committee Consultant; and

WHEREAS, during the process of securing services of a qualified consultant and promulgation of an appropriate agreement, it was determined in recalculating the costs necessary for the Committee and consultant that the total cost would be \$105,000 rather than \$100,000 as previously authorized; and

WHEREAS, it is necessary and appropriate to amend previously adopted Resolution No. R-267727 to reflect the increase in total cost in the amount of \$5,000; and

WHEREAS, it is now appropriate to authorize the City Manager to execute, for and on behalf of the City, an agreement with Jack Pearson, who has been recommended by the City Manager to serve as the consultant; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby fully empowered to execute, for and on behalf of said City, a consultant agreement with Jack Pearson, an individual, for the purpose of providing professional services to the Committee Against Drug Abuse, pursuant to the terms and conditions of the agreement, on file in the office of the City Clerk as Document No. RR- $\frac{268267}{}$

BE IT FURTHER RESOLVED, that section 4. of Resolution No. R-267727, dated February 17, 1987 be and the same is hereby amended to read as follows:

4. That the Auditor and Comptroller be and he is hereby authorized to transfer, at this time, the sum of \$105,000 within the General Fund 100 from the Police Department 11000, Program Element 11010 to Non-Departmental Expense, Committee on Drug Abuse [Department 601, Program Element 60109] for the purpose of consultant expense support and miscellaneous expenses that may be incurred.
