3. That the City Manager is hereby authorized to amend the consultant agreement with DELOITTE, HASKINS & SELLS (DHS);

4. That the expenditure of the deposited funds in the amount of \$10,000 for consulting services of DHS is hereby authorized and approved;


5. That the City Manager is hereby authorized to submit the amendment to the Foreign Trade Zone application, a copy of which is on file in the office of the City Clerk as Document No.
