RESOLUTION NUMBER R- 268276

ADOPTED ON MAY 4 1987

WHEREAS, the City Council has adopted an Uptown Interim Ordinance limiting the issuance of demolition permits and building permits; and

WHEREAS, the Uptown Interim Ordinance requires Planning Director approval of all demolitions permits in Uptown; and

WHEREAS, the Uptown Interim Ordinance requires the approval of a Planned Infill Residential Development Permit or a Planned Residential Development Permit prior to the approval of most building permits for multi-family development in Uptown; and

WHEREAS, administration of the Uptown Interim Ordinance requires the addition of one (1) associate planner position; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Planning Department be directed to authorize the addition of one (1.0) associate planner position utilizing salary savings in the current fiscal year.

2. That the Planning Department be and it is hereby directed to include during City Council review of its fiscal year 1987-88 budget a supplemental request for one (1.0) associate planner for the reasons expressed in the preamble hereto.
