RESOLUTION NUMBER R- 268290

ADOPTED ON MAY 5 1987

A RESOLUTION OF THE CITY OF SAN DIEGO URGING SUPPORT BY ALL SAN DIEGO COUNTY CITIES, THE CALIFORNIA STATE LEGISLATURE, AND THE GOVERNOR TO ENDORSE CERTAIN LEGISLATIVE PROPOSALS TO GENERATE NEW SOURCES OF REVENUE FOR CRITICALLY NEEDED JUSTICE FACILITIES.

WHEREAS, the Board of Supervisors, on February 11, 1986, declared a state of emergency because of overcrowding within the County detention system; and

WHEREAS, the County Jail System consistently has 1,500 more inmates in custody than the State rated capacity of 2,315 beds; and

WHEREAS, the Sheriff is forced to release over 2,000 inmates each month because of the lack of bed space, thereby threatening the security and quality of life of County residents and visitors; and

WHEREAS, 6,500 additional adult jail beds and 240 additional juvenile beds are projected to be needed by the year 2005; and

WHEREAS, up to 95 additional courtrooms may be required by the year 2005; and


WHEREAS, the estimated cost of required new justice facilities is \$851 million; and

WHEREAS, the County does not have the resources to pay for these facilities; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that The City of San Diego urges the cities within the County of San Diego, the California State Legislature, and the Governor to join together in supporting SCA 13 (Deddeh), the Trial Court Funding Bill, a legislative proposal to enact a Business License Tax in the unincorporated areas of San Diego County, and a limited purpose special district, it being anticipated that said proposals will generate additional revenues which would be dedicated to justice facility construction and operation.
