RESOLUTION NUMBER R- 268303 ADOPTED ON MAY 11 1987

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provide a procedure for the summary vacation of streets and public service easements by City Council resolution where for a period of five consecutive years, the street or highway has been impassable for vehicular travel and no money was expended for maintenance on the street or the street or highway during such period; and

WHEREAS, the abutting property owners have requested the vacation of Federal Boulevard between "F" Street and 33rd Street; "G" Street east of 33rd Street; and the alley in Block 144 of Choate's Addition Map 167; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the street to be vacated will continue to have access; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Federal Boulevard, "G" Street and the alley in Block 144 of Choate's Addition, Map 167 as more particularly shown on

Drawing No. 16959-B on file in the office of the City Clerk as Document No. RR-268303-1, which is by this reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

- 2. That the resolution shall not become effective unless and until a consolidation parcel map for the affected parcels has been recorded in the office of the County Recorder. In the event the consolidation parcel map is not recorded within three (3) years from the adoption of this resolution, this resolution shall become void and be of no further force or effect.
- 3. That the City Engineer shall advise the City Clerk of the approval of the consolidation parcel map, and that the City Clerk shall then cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.






