City of San Diego, a quitclaim deed, which is on file in the $^{\prime}$ office of the City Clerk as Document No. RR- 268304 , quitclaiming to SAN DIEGO GAS & ELECTRIC COMPANY, a California corporation, as owner of Lots 2 through 6 of Block 1 of Sunnydale, Map 419; a portion of Lot 25, Block 144, Choate's Addition, Map 167; and a portion of Parcel 2 of Parcel Map 14227, effecting the revestment of those abutter's rights of access in and to Federal Boulevard of said Lots 2 through 6 of Block 1 of Sunnydale, Map 419; Lot 25 of Block 1 of Choates Addition, Map 167; and Parcel 2 of Parcel Map 14227, heretofore relinquished to the City, as more particularly described in said quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution, attested by him under seal, to the Engineering Department for further handling.
