RESOLUTION NUMBER R- 268306

WHEREAS, MONTORO-LA JOLLA HOMEOWNERS ASSOCIATION has requested an exchange of drainage easements; and

WHEREAS, the City Manager has previously accepted a deed of Montoro-La Jolla Homeowners Association conveying a drainage easement to the City; and

WHEREAS, the City Manager has certified that the values of the property rights to be exchanged are equal; and


WHEREAS, the easement acquired will serve the same use and purpose as the easement to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 268306, quitclaiming to MONTORO-LA JOLLA HOMEOWNERS ASSOCIATION all of the City's right, title and interest in the drainage easement in Lot 44 of Montoro, Map No. 8447, as more particularly described in said deed.

2. That the City Clerk is hereby authorized and directed to deliver the quitclaim deed, and a certified copy of this resolution, attested by him under seal, to the Engineering and Development Department for further handling.
