WHEREAS, the Third Annual Lake Murray Community Park Picnic is scheduled for Saturday, May 23, 1987; and

WHEREAS, fishing on Saturday, May 23, 1987 will be open only to children twelve years of age or younger; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Saturday, May 23, 1987 be and it is hereby declared as "Children's Fishing Day at Lake Murray."

BE IT FURTHER RESOLVED, that the permit fees required to engage in fishing shall be and they are hereby waived for children on Saturday, May 23, 1987.

BE IT FURTHER RESOLVED, that Sunday, May 24, 1987 be declared to be the opening day of fishing in Alvarado Bay at Lake Murray to the general public wherein fees will be charged.
