BE IT RESOLVED, by the Council of The City of San Diego, that the expansion of the said boundaries is hereby approved to include:


1. Park Boulevard: Meade to Adams and on Adams from Park Boulevard to Florida.
2. El Cajon Boulevard: I-805 to 54th Street.
3. 30th Street: Lincoln to Meade and Madison to Adams.

BE IT FURTHER RESOLVED, that the Adams Avenue boundaries are hereby amended as follows:

Kansas to Ohio, and Bancroft to Wilson.
