
RESOLUTION NUMBER R- 268316

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$103,267 from CIP No. 37-321.0, Advanced 800 MHZ Communications System, is hereby authorized, solely and exclusively for the above project and authorizing the City Auditor and Comptroller upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
