RESOLUTION NUMBER R- 268318

WHEREAS, a Memorandum of Understanding for fiscal year 1988 has been agreed to by the San Diego Municipal Employees Association [MEA] for the Professional, Supervisory, Technical and Administrative Support and Field Service Units; and

WHEREAS, the following employee organizations agreed to two-year Memoranda of Understanding for the specified units for the period July 1, 1986 through June 30, 1988, copies of which are on file in the office of the City Clerk:

1. Local 127, American Federation of State, County, and Municipal Employees, AFL-CIO for Maintenance and Labor, and Skilled Trades and Equipment Operator Units [Document No. RR-265707-2];

2. San Diego Police Officers' Association for the Police Unit [Document No. RR-265707-3];

3. Local 145, International Association of Fire Fighters for the Fire Unit [Document No. RR-265707-4];

and

WHEREAS, it is now necessary and appropriate to approve the Memorandum of Understanding agreed to by the Management Team and representatives of the employee organization impacted herein [MEA] and recognize the continuance of the Memoranda of Understanding with the three employee organizations for the second year extending through June 30, 1988; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council of The City of San Diego hereby endorses and approves the Memorandum of Understanding agreed to by the Management Team and representatives of the Municipal Employees Association, all pursuant to the provisions of the Memorandum of Understanding on file in the office of the City Clerk as Document No. RR- 268318

BE IT FURTHER RESOLVED, that the Memoranda of Understanding with Local 127, American Federation of State, County, and Municipal Employees, AFL-CIO; San Diego Police Officers' Association; and Local 145, International Association of Fire Fighters; all previously agreed to and approved effective July 1, 1986 for two-year periods expiring June 30, 1988, copies of which are on file in the office of the City Clerk as Documents No. RR-265707-2, RR-265707-3 and RR-26707-4 respectively, be and the same are hereby legislatively noticed as to their provisions and endorsed for the second year of their respective terms to expire June 30, 1988.
