RESOLUTION NUMBER R- 268323
ADOPTED ON MAY 11 1987

WHEREAS, the United States Gymnastics Federation's (USGF) Western Elite Classic Meet will be hosted by San Diego State University on May 16 and 17, 1987; and

WHEREAS, this is a major meet consisting of from sixty to sixty-five female gymnasts representing teams from a 25-state area west of the Mississippi River; and

WHEREAS, this meet is a step toward qualifying gymnasts to the Elite Nationals and then ultimately to the USA Championships; and

WHEREAS, these Elite gymnasts are those who go on to become members of the United States National and Olympic teams; and

WHEREAS, this is the first time ever that a USGF Elite Meet has been held in San Diego; and

WHEREAS, this type event closely relates to efforts by The City of San Diego's United States Olympic Training Center Site Ad Hoc Task Force in promoting San Diego as a site for such activities; and

WHEREAS, there are three San Diego State Aztecs competing in this event: Michelle Colavin, Annie Dixon, and Julianne Bauer; NOW, THEREFORE,


