BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for STREET LIGHT CONVERSIONS - CITYWIDE CONTRACT NO. 4.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$568,000 from Special Litigation Reserve Fund 65011, CIP No. 37-317 SDG&E STREET LIGHTING ACQUISITION AND CONVERSION is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in Special Litigation Reserve Fund 65011, CIP No. 37-317 SDG&E STREET LIGHTING ACQUISITION AND CONVERSION.
