

RESOLUTION NUMBER R- 268331

ADOPTED ON MAY 18 1987

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish, in accordance with law, notice to contractors calling for bids for one (1) complete audio verification system including 22 field recorders, 1 verifier, 1 station recorder, 1 duplicator, 1000 audio cassette tapes, 2 transcribers and video monitoring equipment including 2 video monitors, 2 video recorders, 2 video cameras, 2 video camera lenses, 4 wall brackets and 2 time/date generators.

2. That the City Manager is hereby authorized to execute a contract with the lowest responsive and reliable bidder to furnish an audio verification system including 22 field recorders, 1 verifier, 1 station recorder, 1 duplicator, 1000 audio cassette tapes, 2 transcribers and video monitoring equipment including 2 video monitors, 2 video recorders, 2 video cameras, 2 video camera lenses, 4 wall brackets and 2 time/date generators.

3. That the expenditure, not to exceed \$33,140 from Fund 10132 Seized and Forfeited Assets, is hereby authorized solely and exclusively for the purchase of an audio verification system including 22 field recorders, 1 verifier, 1 station recorder, 1

duplicator, 1000 audio cassette tapes, 2 transcribers and video monitoring equipment including 2 video monitors, 2 video recorders, 2 video cameras, 2 video camera lenses, 4 wall brackets and 2 time/date generators.
