RESOLUTION NUMBER R- 268335

ADOPTED ON MAY 18 1987

WHEREAS, DONALD L. BREN COMPANY, a California corporation, J.M. PETERS COMPANY, a California corporation, and STAFFORD HANNON C/O ALICE L.G. INGLEDUE, have requested an exchange of water easements; and

WHEREAS, the easements being abandoned are of greater value than those being dedicated; and

WHEREAS, the fair market value of the difference between the easements being abandoned and those being dedicated is ELEVEN THOUSAND NINE HUNDRED FIFTY DOLLARS (11,950,000), which amount has been deposited with the City; and

WHEREAS, the easements to be acquired will serve the same use and purpose as the easements to be quitclaimed by the City; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the acceptance by the City Manager of those deeds of DONALD L. BREN COMPANY, a California corporation, J.M. PETERS COMPANY, a California corporation, and STAFFORD HANNON C/O ALICE L.G. INGLEDUE, executed in favor of The City of San Diego, conveying to said City water easements in the Southeast Quarter of Section 12, T.14.S., R.3.W., S.B.M., as more particularly described in said deeds, copies of which are on file in the office of the City Clerk as Document Nos. RR-268335-, / RR-268335-² and RR-268335-³ is hereby approved.

2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No.

RR-268335-7 quitclaiming to DONALD L. BREN COMPANY, a California corporation, J.M. PETERS COMPANY, a California corporation, and STAFFORD HANNON C/O ALICE L.G. INGLEDUE, all of the City's right, title and interest in the water easements in the Southeast Quarter of Section 12, T.14.S., R.3.W, S.B.M., as more particularly described in said deeds.

3. That the City Clerk is hereby authorized and directed to deliver all the deeds, and a certified copy of this resolution to the Engineering and Development Department for further handling.

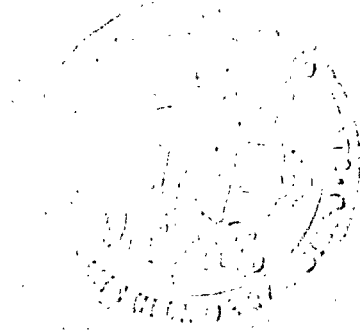
