WHEREAS, the vacation of the City's interest in an unneeded water easement affecting a portion of Parcel 1 of Parcel Map No. 14576, as more particularly shown on Drawing No. 16836-B attached hereto as Exhibit "A", has been requested by the affected property owner; and

WHEREAS, the owner wishes to clear title to his land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easement has never been used, and is surplus to City needs; and



BE IT RESOLVED, by the Council of The City of San Diego, as follows:

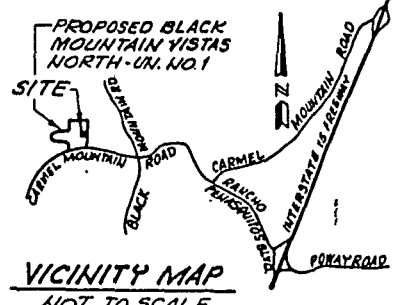
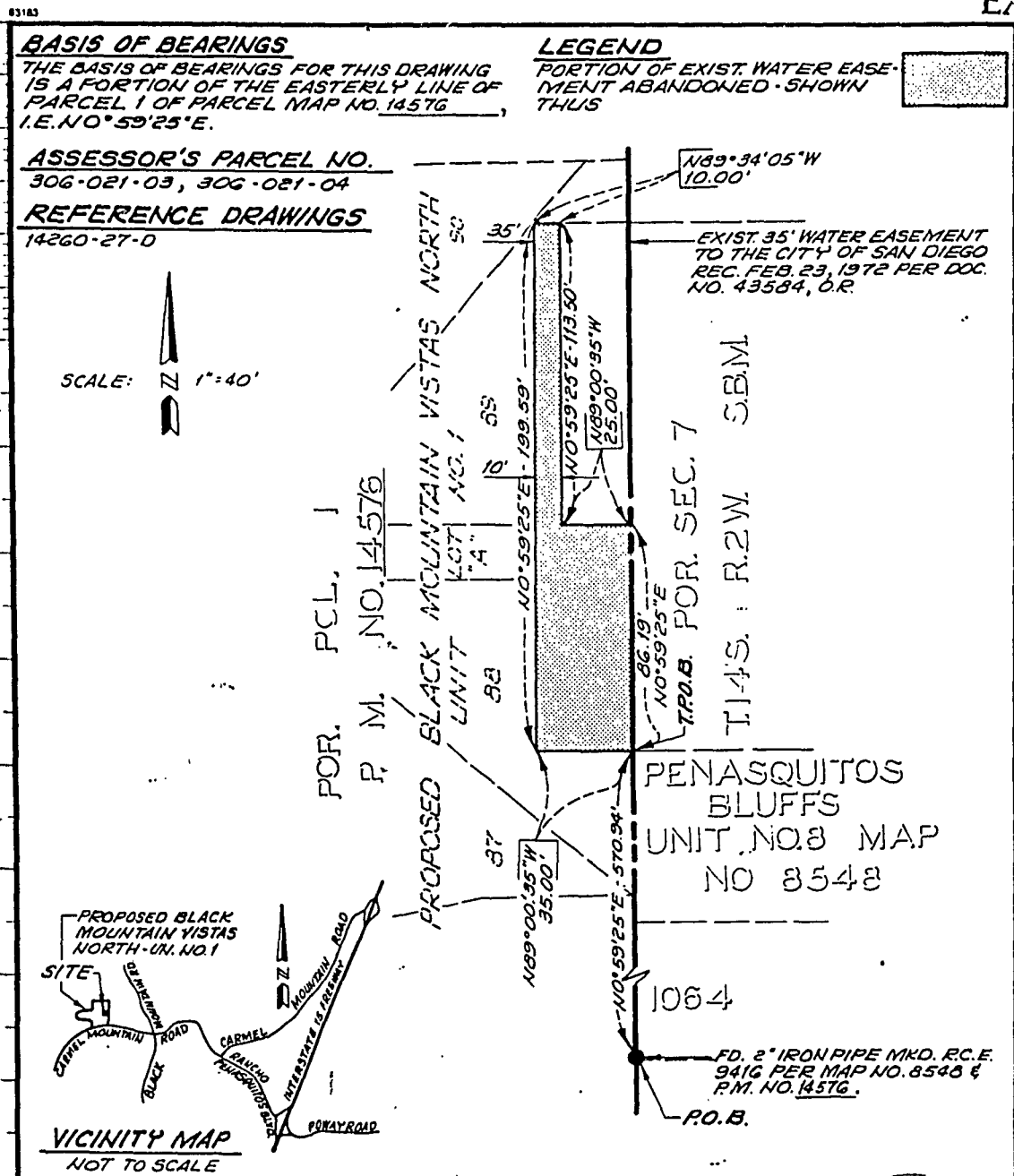
