RESOLUTION NUMBER R- 268342

ADOPTED ON MAY 18 1987

APPROVING PARCEL MAP NO. TM-86-0754.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Phillip S. Butcher, Licensed Land Surveyor, entitled "PARCEL MAP NO. TM-86-0754 being a lot line adjustment of Lots 34 through 46 inclusive of Carmel Valley - Unit No. 7, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 11544, filed in the office of the County Recorder of San Diego County, June 19, 1986, together with Wispering Woods Court as closed and vacated to public use excepting therefrom: all oil, gas, minerals and other hydrocarbon substances lying below the depth of 500 feet from the surface but without the right of entry upon any portion of the surface of the above described properties, reserved by deed recorded July 1, 1986 as File No. 86-271954 of official records," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Wispering Woods Court and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.


That said Council hereby accepts on behalf of The City of San Diego, the easement(s) listed in paragraph 1 .of the Owner's Certificate as shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street is accepted on behalf of the public as heretofore stated; and those easements listed in paragraph 1 of the Owner's Certificate, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the or Clerk of the Board of Supervisors of the County of San Diego, California.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of a portion of Wispering Woods Court, approved by Council Resolution No. R-268130, on April 20, 1987, concurrently with the filing of the map.
