RESOLUTION NUMBER R- 268348

ADOPTED ON MAY 18 1987

WHEREAS, at its meeting of August 12, 1985, the City Council directed the City Manager to develop a Child Day Care Policy and submit it to the Council for its approval; and

WHEREAS, in a request for Council action (CM-1472) dated August 27, 1985, and in City Manager's Report No. 85-433, dated September 4, 1985, the City Manager recommended that the Council adopt the Child Day Care Policy that was attached to the City Manager's report; and

WHEREAS, the recommendation was approved by City Council at its meeting of September 9, 1985, however, due to an administrative oversight, the implementing resolution was not submitted or approved; and

WHEREAS, it has been the understanding and intent of Council members, City staff, and the public that the Child Day Care Policy had been adopted on September 9, 1985 and accordingly, Council members have since made public references to the policy, and staff has made copies available to public and private agencies and individuals; and


