

RESOLUTION NUMBER R-268368

ADOPTED ON MAY 19, 1987

WHEREAS, on March 10, 1987, the Council of The City of San Diego (the "Council") approved the Local Coastal Program implementing ordinances, but continued to April 7, 1987, and then to May 19, 1987, certain matters as set forth in Council Resolution No. R-267849; and

WHEREAS, on May 19, 1987, the Council held a public hearing to consider the Planning Department recommendations pertaining to those certain matters as referenced above; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the establishment of the consent agenda procedure described as Alternative 3 in Planning Report No. 87-235 for the processing of Local Coastal Development Permits in the area formerly designated as "categorical exclusion" area, is hereby approved.


2. That the Planning Department is directed to administer the Local Coastal Development Permit process on a full cost recovery basis to the maximum extent practicable.

3. That the recommendation of John Thelan (letter dated March 10, 1987) to include single-family residences as a permitted use in the Sensitive Coastal Resource Overlay Zone - bluff areas, is hereby approved.

4. That the recommendation of Nancy Lucast (revised letter dated March 27, 1987) to allow a Conditional Use permit for the reconstruction of existing private recreational facilities located in the A-1/FPF Zone, under specific conditions, is hereby approved.
