WHEREAS, this is the third season the girls' basketball team has been undefeated with a 34-0 record; and

WHEREAS, Terri Mann has broken rebounding records with a career high of 2,256, finishing this season with 816 rebounds and breaking the previous record of 672 rebounds set by an Olympic team player; and

WHEREAS, Terri Mann has also set section records for career scoring (3,188) and season scoring (1,176), averaging 37.7 points per game; and

WHEREAS, Terri Mann was voted CIF-San Diego Section Girls' Basketball Player of the Year and has won the solo Athlete of the Year honor in the sport for three straight years; and

WHEREAS, Terri Mann has exhibited the skills of leadership and team spirit which have rallied the Lady Pointers to a team effort, ending their past four years with a team record of 122 wins to 1 loss; NOW, THEREFORE,
