

RESOLUTION NUMBER R- 268381

ADOPTED ON MAY 26 1987

BE IT RESOLVED, by the Council of the City of San Diego that the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for CONSTRUCTION OF TRAFFIC SIGNAL MODIFICATIONS AND INTERCONNECT ON MIRAMAR ROAD BETWEEN EASTGATE MALL AND KEARNY MESA ROAD, San Diego, California, filed in the office of the City Clerk of the City of San Diego, California, on May 26, 1987, and bearing official Document No. W.O. 118801, be and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for CONSTRUCTION OF TRAFFIC SIGNAL MODIFICATIONS AND INTERCONNECT ON MIRAMAR ROAD BETWEEN EASTGATE MALL AND KEARNY MESA ROAD.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$170,000 from the Gas Tax Fund 30219.1, Job Order 32222 to CIP No. 62-237.1 MIRAMAR ROAD MASTER CONTROL SYSTEMS PHASE II.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$229,000 from CIP No. 62-237.1 MIRAMAR ROAD MASTER CONTROL SYSTEMS PHASE II (\$59,000 from Revenue Sharing Fund 18013 and \$170,000 from Gas Tax Fund 30219.1) is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
