

RESOLUTION NUMBER R- 268387

ADOPTED ON MAY 26 1987

APPROVING MAP OF CANYON HILLS P.R.D.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by W. R. Nothomb, Licensed Land Surveyor, entitled "CANYON HILLS P.R.D. being a subdivision of portions of Section 20 and 29, Township 14 South, Range 2 West, San Bernardino Meridian, according to official plat thereof, and Parcel 1 of Parcel Map 13508, all in the City of San Diego, County of San Diego, State of California, together with Mercy Road, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Alemania Road, Bolseria Lane, Canaleja Way, Borne Court, Colo Court, Justo Court and Taray Court and said street(s) are hereby declared to be public street(s) and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Alemania Road, adjacent and contiguous to Lot 94, in and to Colo Court, adjacent and contiguous to Lots 107 through 112, inclusive, and

in and to Mercy Road, adjacent and contiguous to Lot 119, all as shown on the map within the subdivision.

That said Council hereby accepts on behalf of The City of San Diego, the easement(s) listed in paragraphs 2 and 3 of the Owner's Certificate as shown on the map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, the building restricted easement(s) over, upon or across all of Lots 114, 115, 116, 117, 118, 119, 120, 121, 122, 123, 124, 126, 127 and Lot "A," as granted and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street(s) are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with those easements listed in paragraphs 2 and 3 of the Owner's Certificate, and the building restricted easement(s), all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
