RESOLUTION NUMBER R- 268389

APPROVING MAP OF CARMEL MOUNTAIN RANCH UNIT
NO. 7A.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That said Council hereby finds that certain map surveyed by Leroy C. Bodas, Registered Civil Engineer, entitled "CARMEL MOUNTAIN RANCH UNIT NO. 7A being a subdivision of portions of Parcels 1, 2 and 3 of Parcel Map No. 14091 according to parcel map filed in the office of the County Recorder of San Diego County, December 26, 1985 as File No. 85-487412 of official records, in the City of San Diego, County of San Diego, State of California, together with Alta Carmel Court as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Avenida Venusto, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

That said Council hereby accepts on behalf of The City of San Diego, any and all abutters' rights of access in and to Paseo Lucido, adjacent and contiguous to Lot 1, and in and to Avenida Venusto, adjacent and contiguous to Lot 1, all as shown on the map within the subdivision.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a street is accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, all as granted and shown on the map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
