RESOLUTION NUMBER R- 268402

ADOPTED ON MAY 26 1987

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Lots 3, 5 and 6 of Casa New Salem Unit No. 2, Map No. 9130, for access from Westonhill Drive and Mira Mesa Boulevard; and

WHEREAS, the Engineering and Development Department has requested that the City revest these abutter's rights of access in the property to PARDEE CONSTRUCTION COMPANY, a California corporation, to allow better utilization of the land; and

WHEREAS, said abutter's rights of access are no longer needed by the City and should be revested in the property; and

WHEREAS, it has been determined that all affected City departments have no objection to the revestment of said abutter's rights; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on

file in the office of the City Clerk as Document No. RR-268402
quitclaiming to PARDEE CONSTRUCTION COMPANY, effecting the
revestment of abutter's rights of access acquired per Map Nos.
6954 and 9130 in and to Lots 3, 5 and 6 of Casa New Salem Unit
No. 2, Map No. 9130, for access from Westonhill Drive and for a
60' emergency access from Mira Mesa Boulevard, as more
particularly described in the quitclaim deed.

BE IT FURTHER RESOLVED, that the City Clerk is hereby
directed to deliver the deed and a certified copy of this
resolution, attested by him under seal, to the Engineering and
Development Department for further handling.
