WHEREAS, the California Conservation Corps (CCC) is well known throughout San Diego county for its public service work and has contributed significantly to the restoration and preservation of our natural resources; and

WHEREAS, in December 1980, Terrance J. Edmonson helped open the Franklin D. Roosevelt (FDR) Center of the CCC as a procurement officer and recruiter; and

WHEREAS, he returned to the FDR Center in 1982 as a supervisor and has been a crew supervisor of public works and projects in the San Diego area since then; and

WHEREAS, his many crew accomplishments include the management of the 1983 San Diego floods, flood-control in Los Coches Creek and leading flood crews along the California-Arizona border; and


WHEREAS, in addition, he led the cleanup crews after the 1985 Normal Heights fire, and in conjunction with the California Department of Forestry and the United States Forest Service, helped to restore pine tree plantations in the Laguna Mountains; and

WHEREAS, in his capacity as training officer for community service duties, Mr. Edmonson has worked closely with street youth gangs, the March of Dimes, the Registrar of Voters and the Barrio Station and has also provided the support and training for, among others, the San Diego City Corps and the Triple Crown Brush Management Program during the summer of 1986; and

WHEREAS, by virtue of his supervisorial, role model and leadership skills, he has made the mission of the CCC successful in the San Diego area and deserves the gratitude and appreciation of the people of The City of San Diego for his numerous efforts on their behalf; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Terrance J. Edmonson be appropriately recognized and on this occasion of his transfer to the California Conservation Corps - Pomona Center, be sincerely thanked for his contribution to our community and wished the best of luck in his new endeavors.
