RESOLUTION NUMBER R- 268410

ADOPTED ON MAY 26 1987

WHEREAS, the San Diego County Sheriff is applying for a grant of \$181,383.04 from the State of California's Foundation for Community Service Cable Television; and

WHEREAS, the purpose of this grant is to enable the Sheriff to develop video programming to be shown on the cable television public access channels; and

WHEREAS, the programming to be developed will be directed at educating the public in the areas of crime reporting and crime prevention, as well as to serve as a public information outlet for local law enforcement agencies; and


WHEREAS, most of the grant funds will be used for the purchase of certain basic video production equipment such as cameras and editing equipment and this equipment will be available for use by other law enforcement agencies in the County; and

WHEREAS, this grant has the support of the San Diego Police Chief; NOW, THEREFORE,
