WHEREAS, the Council unanimously determined and decided in closed session that the employment of outside counsel was appropriate for the <u>Moore</u> case and authorized an allocation of \$25,000 for said outside counsel in accordance with the proposal of outside counsel to the City Attorney, dated April 9, 1987; and

WHEREAS, the Council further determined and decided that the sum of \$10,000 be allocated for the prosecution by outside counsel of the Horseman's Park case; and

WHEREAS, it is now necessary to set aside the monies recited above for said cases, pursuant to the authority of the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Auditor and Comptroller be and he is hereby fully authorized to transfer within the General Fund 100, the sum of \$35,000 from the Unallocated Reserve (605) to the Allocated Reserve (901) to be used solely and exclusively for providing funds for outside counsel in connection with litigation of the superior court cases

entitled, Moore, et al. v. City of San Diego [\$25,000] and City of San Diego v. Horseman's Park [\$10,000].
