BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$70,000 from Fund 30219 Gas Tax, CIP No. 52-379 "Citywide Alley Projects" and \$2,400 from Fund 41506, CIP No. 44-001 "Sewer Main Replacement Annual Allocation," is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
