
RESOLUTION NUMBER R- 268424

ADOPTED ON MAY 26 1987

BE IT RESOLVED, by the Council of The City of San Diego, that until the PENASQUITOS EAST COMMUNITY PLAN update has been reviewed and approved by the City Council, no developments within the community plan area shall be approved if the dwelling unit density of the project exceeds the midrange of the density identified in the community plan for the area in which the proposed development is located. This action is necessitated by the fact that developments within the residential areas are typically being proposed at the maximum density specified in the community plan when the community plan anticipated a range of densities. The use of the maximum density is resulting in the development of dwelling units the number of which exceeds the number anticipated by the community plan.
